## **Start-up Nations - Innovative Entrepreneurship for Sustainable Development**

### **International conference Geneva, 2 November 2016**

In September 2015, the General Assembly of the United Nations adopted the 2030 Sustainable Development Agenda, an ambitious clarion call that commits the countries of the world to achieve economic prosperity while protecting our planet and without leaving anyone behind.

This ambition, to achieve economic growth in an ecologically sustainable and socially inclusive way, cannot be realized with business as usual. It requires new ways of producing and consuming and of organizing our lives. It requires moving to clean technologies, renewable energy, and the circular economy.

The 2030 Agenda for Sustainable Development recognizes the enormous opportunities which innovation offers for achieving its goals. It also recognizes the business community's central role in driving innovation for sustainable development and indeed calls for a renewed partnership between governments and the business community.

While large established companies typically account for the bulk of spending on and employment in research and development, truly path-breaking, disruptive innovation often comes from newly created start-up companies which are unencumbered by legacy systems and have the flexibility, but also the appetite for risk, necessary to move into uncharted territory. Indeed, UN General Assembly resolution 69/210, which was sponsored by the Government of Israel, recognizes the important contribution entrepreneurship can make to sustainable development by creating jobs and driving economic growth and innovation. Some of the unique features of Israel's innovation ecosystem encouraging Entrepreneurship and Innovation will be showcased during the conference.

Every day, all over the world, ambitious, creative entrepreneurs are starting companies with the potential to make a difference to sustainable development, to have a positive impact on prosperity, people and our planet in areas as diverse as agriculture, energy, environment, or health, to name but a few. But much more needs to be done, and much more can be done.

The conference will bring together innovators from the private and the public sector from throughout the UNECE region to celebrate the power of disruptive innovation in aligning economic growth with ecological sustainability and social inclusion. It will also discuss how we can get (even) better at it.

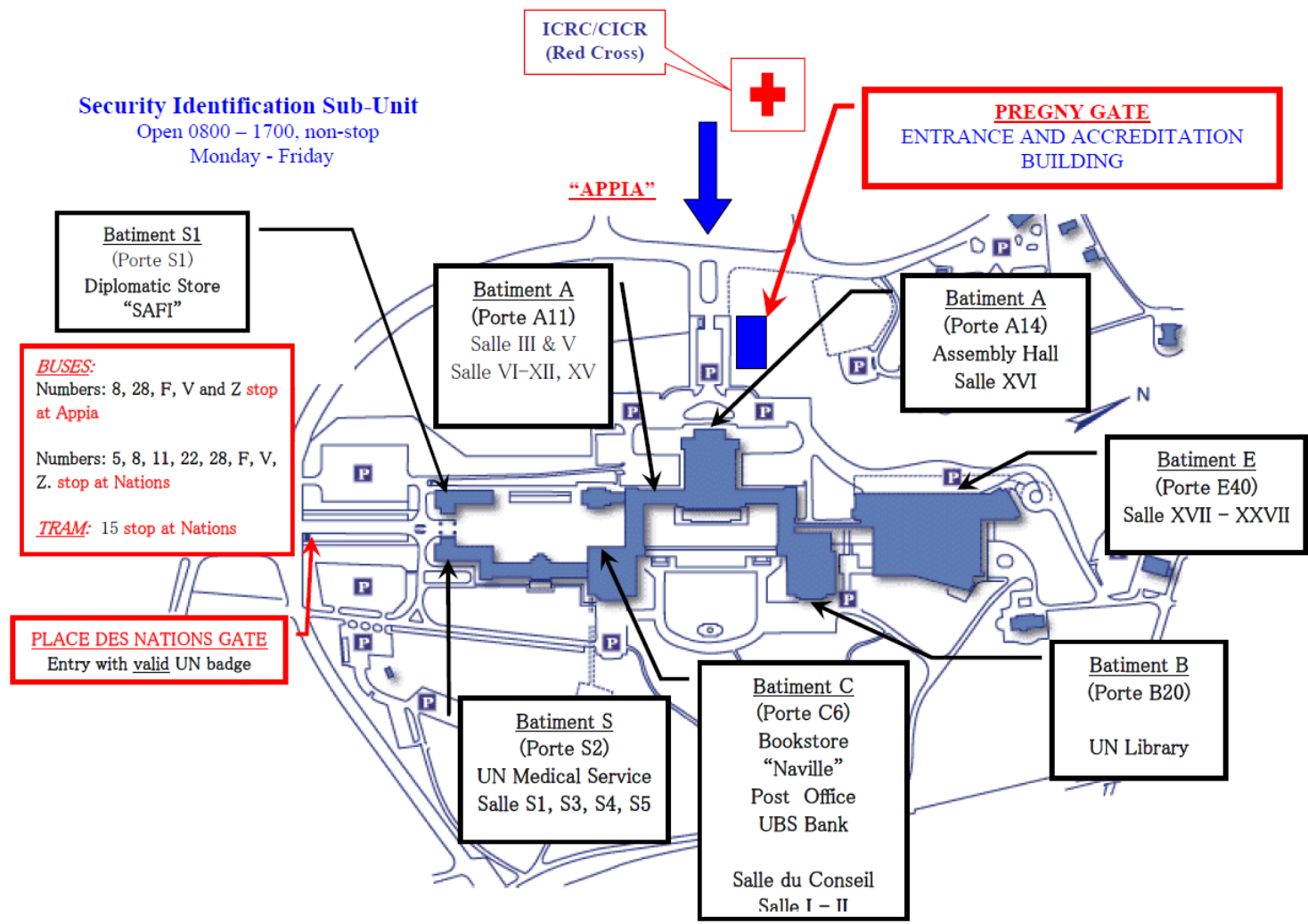
