Israeli Economy Grows Faster than Expected

The Israeli economy grew by 3% on an annualized basis in the first quarter of 2012, the Central Bureau of Statistics reported in May. The growth rate was above the 2.5% growth predicted in a "Bloomberg" poll of analysts, GDP growth in the first quarter was nevertheless less than in the two preceding quarters: 3.2% in the fourth quarter of 2011 and 3.3% in the third quarter.

Israel and India to Launch Joint Academic Program

Minister of Finance, Dr. Yuval Steinitz, and Minister of Education, Mr. Gideon Saar, with India's Minister of Education and Human Resource Development, Mr. Kapil Sibal, announced the extension of research and academic cooperation between the two countries, and the launch of a joint Israeli - Indian academic program. The new joint program would be budgeted at \$10 million annually, for an unlimited time.



Ministry of Finance Announces New Tax Benefits to Encourage the Use of Hybrid and Electric Vehicles

Minister of Finance **Dr. Yuval Steinitz** has decided to grant additional tax benefits for vehicles with alternative (hybrid or electric) drives, with the aim of continuing to promote the market penetration of these vehicles. The Minister of Finance's decision was made as part of the Tax Authority's policy of promoting the use of environment friendly vehicles by means of tax incentives ("green taxation").

Experts Say Israel is Set to Leap Forward as a Biotech Leader

If the '90s was the decade of the dot-com boom, and the "aughts" (200-2010) the decade of Web 2.0, the current decade is shaping up to be the biotech decade - and Israel is set to play a pivotal role in the medical revolution that is just beginning to bubble up to the surface.

OECD Report on Developing Cleantech Industry in the Negev Holds Great Promises for the Future

The OECD researchers discovered, for example, that in the Negev region alone there are some 50 active cleantech companies, twice as many as in any other part of Israel. They found that, in the Negev, there are four technology incubators, university research departments, and independent research centers, representing a third of all the cleantech research activity in the country. At the same time, private investment in cleantech in Israel is on the rise.
